SCHEDULE A – FEES AND FINES TARIFF

Except for rules 6.J, 8.H and 9.E, a formal written charge will be issued to the club concerned. Sanctions will then be levied in Accordance with the decisions of the Discipline Sub-committee (endorsed by the Management Committee). In this connection, it is important for clubs to reply to charge letters/emails as fully as possible to include all mitigating circumstances. The **FINES TARIFF** gives an indication of the **MAXIMUM** possible. For example, it would be extremely unlikely that for Rule 18.K a club would be fined £100 or for Rule 20.E.1 £250 unless there had been multiple offences or where previous breaches of the rule had occurred.
